Members considered the financial position reported at the last meeting and agreed:

Purchase of new computer/software and ancillary equipment up to the value of £750 (as Clerks old computer needed replacement)

Agreed Cllr Powell would draw up a schedule of works required at the Institute Building (including decoration)

Clerk to try and obtain Property

**Condition Survey from CCBC** so any relevant issues identified can be incorporated into the works schedule so all repair/refurbishment/redecorations can be commissioned.

Cllr Blackman suggested the provision of lights at the skate park (agreed Council would consider when more information was provided)

The Clerk sought some guidance from Members regarding setting the budget/precept for next year (especially in light of the uncertainly regarding the feasibility of opening the toilets and potential costs if a grant is not available. It was suggested (subject to report in January) that any increase in Precept be kept to about 2% with any budget deficit being accommodated from reserves (for this coming year) or until there is more certainly regarding ongoing costs.

## 2478 Consider CCBC Budget Proposals

Members reaffirmed the list previously provided and agreed the Clerk should write to CCBC with suggestions of how the removal of savings should be funded. (use of 50% of saving made in advance (using historical data) plus use of 50% of the difference in budgeted council tax collection and the actual collected in previous years

### 2479 Innovative Drainage systems (requested by Cllr Blackman)

The Clerk presented the recent article included in Newsline and the document received from Welsh Government.

#### 2480 To receive update report on Public Toilets
