The Clerk reported that he had sought advice from the CCBC Monitoring Officer regarding item 1869 (ongoing correspondence regarding appointment of Cleaner).

The advice received confirmed the Monitoring Officer had no formal powers to act in this matter and that if the complainant wishes to pursue this matter then we could send a final notification confirming we will not be corresponding with them in future and that if they remain dissatisfied the should refer to the PSOW.

It was confirmed at a recent training event that if we receive any further correspondence we would also be within our rights (Under FOI legislation) to ask that they provided formal identification.

It was agreed unanimously that we would not enter into further correspondence (unless we are contacted again) and if this happens we will require them to provide evidence of their identity. Upon receict of this information we will confirm we believe we have answered all questions relating to this matter, will not be entering into further correspondence and advise them they could seek advice from the Public Services Ombudsman for Wales if they are dissatisfied.
