## 1770. Report from the Chairman:

The Chair reported that a call had been received from Cor Rhosyn Ladies Choir enquiring of the availability of the community room for practicing purposes due to them not having a venue for their preferred time of meeting each week, this is due to the closure of Salem Chapel. Information to be provided regarding room availability and also details of other venues that may be suitable in the area. Members agreed that we are to support where possible to ensure the choir is not in a position of having to disband.

A further call from the Secretary of Nelson Historical Society confirming that due to the closure of Salem Chapel they no longer have a place to store the Historical Society artefacts and would we be willing as a council to house their lockable storage cupboard. Members agree that subject to measurements we would be willing to accommodate this.

Information had been received from Cllr. P Baldwin and distributed by the Chairman regarding LDP and in particular a letter written by our MP for Caerphilly Wayne David to the interim Chief Executive Officer Mr Chris Burns giving his response to the LDP. A letter that had be formulated by neighbouring Councillors and distributed to residents of Penybryn was also provided as an example of Councillors informing their residents of what was happening locally. The Chairman wished thanks to be noted to Cllr. Baldwin for providing this useful information.

Chairman, Vice-Chairman and Clerk attended Planning Aid Wales training that was very informative and gave a good level of information regarding the proposed changes to the way in which we are involved with planning. The Chairman had collected workbooks for distribution to all council members who were not in attendance at the training event.

Information from Nelson Tae kwon Do, who have qualified again to compete at the European Championships was received. There are three Nelson Residents who will be representing Nelson and attending. A Grant Aid form has been provided to raise funds to cover the cost of attendance for the representatives. Chairman expressed on behalf of all members how proud we are and that they have our full support.

Chairman announced the news that our local resident and nelson boxing club member Gavin Gwynne has won the Welsh Amateur Boxing Title for the 64kg weight category. Chairman and all members have expressed how proud they are of his achievement and that the boxing club and its members continue to have our full support. A meeting is to be held to further discuss any recognition to be made regarding this exceptional achievement.

Chairman confirmed that the event held in honour of our retiring clerk was very enjoyable and thanked all members who were present. She also thanked all members including those not in attendance for their support of the recognition for our retiring clerk. She said again that it is to be noted that the retired Clerk Mr A. Hoskins would be sorely missed and that all members were very grateful for his years of dedicated service to the council and wider community.
