# **Apologies for Absence:**

There were no apologies for absence.

# 1757. Report from the Police representative:

PCSO Williams tabled a written report, the content of which was noted.

He also reported that two open backed transit vehicles had been stolen from the Nelson area. There had been no adverse issues associated with the visit of the Fair.

# **Questions/Comments from Members:**

Cllr. Gray noted that the meeting at the Infant's School in relation to parking issues needed to be progressed. Cllr. Mahoney commented on alternative approaches taken by different Inspectors to the same issues which were affecting the community.

Cllr. Davies asked whether the Mobile Police Station could visit the mountain housing sites as many residents living there were unable to attend at the Mabon Road car park location.

Cllr. Lewis reported on some issues that were affecting Mrs Tucker in Ash Grove.

The Chairman thanked the officer for his attendance and report.

Cllr. Miles arrived.

The Chairman invited the representatives from Urdd to report as one of the members was returning to Aberystwyth that evening.

# 1766. Reports from Nominated Members of External Organisations: (Urdd representatives)

Mr Morys Gruffydd (Eisteddfod Organiser for South and West Wales) thanked the Community Council for its continued support. He reported that arrangements were well in hand for the event which would take place during the school half-term break, from 25<sup>th</sup> to 30<sup>th</sup> Mav.

- Premises Licences had been obtained for entertainment only.
- A postponement of proposed repair works to the A472 Flyover had been agreed until after the event had taken place.
- The Traffic Management Plan preparation was ongoing.
- A booklet about the event was being produced and would be circulated to local schools.
- Posters and bunting would be available. Cllr. Baldwin agreed to accept delivery of these items. The Clerk commented that the erection of bunting would require professional assistance.
- Gareth Williams would be liaising with local businesses about the event.
- Cllr. Gray commented that it appeared to be the case that the village and its businesses
  might not see a significant benefit if visitors were being transported to and from the event
  by shuttle bus. It was agreed that the bus operator should be requested to make a stop
  within the village so that visitors could visit the local area and its businesses.
- Cllr. Lewis suggested that land at Ty Du might have been used as a camping/caravan area. Mr Williams had proposed that use of land at Penallta Park but this did not appear to have been taken forward. Cllr. Blackman agreed to enquire about this.
- The Clerk was asked to circulate Mr Williams' email contact details to members.

The Chairman thanked the representatives for their attendance and for the update.

# 1763. CCBC Consultation on the Local Development Plan:

Consideration of this matter was deferred to a Special Meeting to be held on 17<sup>th</sup> March 2015.

# 1764. Governance and Accountability for Local Councils - Internal Audit:

The Clerk reported on changes to the official guidance. A more detailed description was now included on the role of the Internal Auditor, together with an indication on how the function was expected to be carried out. The Clerk would forward a copy to the Council's Internal Auditor for information.

It was noted that the requirements for an Annual Review of procedures, etc., had also been strengthened. This matter would be considered during the new financial year during or following the preparation of the Annual Return.

# 1765. Upgrading of Central Heating Systems at the Institute:

The Clerk had obtained an estimate for the work of upgrading the central heating and hot water systems, including the replacement of the existing gas-fired boiler. Members considered that the work was needed and that three formal quotations should be obtained – from local contractors if possible. It was further agreed that the system supplying the former Snooker Hall should also be checked and any required maintenance, included in the works. The Clerk would action. Quotations would be requested and returned in sealed plain envelopes marked 'Heating Quotation' to be opened by the Clerk and at least two members. Apart from in exceptional circumstances, the best value quotation should be accepted.

#### 1766. Reports from Nominated Members of External Organisations:

Cllr. Gray reported that the Infant's School had recently won the Platinum Eco Friendly Award. It was noted that she had offered the use of the Council Chamber for use by the School Council at

Llancaeach Junior School for one meeting each year. She also proposed to arrange visits to Ty Penallta and the Welsh Assembly building.

Cllr. Miles noted that school governor involvement in a number of aspects of the local schools had recently been increased and become more formalised. Individual governors would now take on a responsibility for certain subject areas.

Cllr. Blackman confirmed that copies of all available minutes of the Community Centre Management Committee that she could access had now been submitted to the Clerk.

Cllr. Davies reported on behalf of the Nelson Development Trust. They had now received keys to the property and registered the lease with the Land Registry. Members of the Trust met with the architect to inspect the building internally and externally. Cllr. Gray reported that further consultation regarding the development of the project would be carried out. She confirmed that minutes of the Trust's formal committee meetings would be forwarded to the Community Council for information.

Cllr. Davies reported on the most recent meeting of the CCBC Standards Committee.

Cllr. Jones and Cllr. Davies reported on a recent meeting of the CCBC JLC.
