## 1809. Report from the Police representative:

Inspector Muirhead reported that the crime figures were down when compared to the monthly average 18 as there had been 13 reported crimes in July and 21 in August. Several of these related to break ins to sheds but these types of incident now seem to have ceased

Anti--Social Behaviour incidents were up slightly on the previous monthly average of 13 whereas there were 16 reported in July and 21 in August (it was not unusual to see an increase during the Scholl Holidays)

Parking was another key issue and it was reported that the Police will continue to enforce although general feedback from the Public and Traders was that they were not happy with this course of action but as time goes on there seems to be more acceptance of enforcement.

The issue of noise from cars was raised as an issue, particularly by the Skate Park where there were 4 calls made in one night.

It was also reported that there had been an incident of children throwing apples in the rear lane of Wern Crescent but this had been resolved when their parents were spoken to.

Off road motorcycling was also identified as a problem and the Police continue to undertake patrols and deal with offenders.

Specific parking issues were identified - outside the Co-Operative

Wern Crescent (vehicles off loading)

Heol Fawr, top of Long Row

It was also reported that large vehicles were parking on the double yellow lines in Shingrig Road which made it very unsafe for other vehicles.

Questions were raised about introducing 20 mph restrictions in the area but it was accepted that this was a County Borough Council decision and this issue together with the possibility of site engineering works to restrict speed would be raised by Cllr Blackman and Cllr Morgan accepting that funding may be an issue.

Inspector Muirhead reported that he would be holding an Inspector's Surgery at Maesycwmmer OAP Hall on the 23<sup>rd</sup> September between 3pm and 5 pm. It was also the intention to hold these at other locations and the Chair offered the use of a room at Nelson Institute when he holds a surgery in Nelson.

Cllr. A Gray (chairperson) reported that the Nelson Community Songs of Praise was very successful and had raised £90

August saw the resignation of the Clerk and the appointment of Mr Tony White who commenced his duties on the 1<sup>st</sup> September although he had been working prior to this date in an attempt to ensure the minutes and Agenda were produced on time.

The Play Group was a great success and oversubscribed. it was reported that numbers were limited 40 attendees (due to restrictions on number of children allocated per Play Worker). There were some complaints as the time advertised for the start was later than the actual start which resulted in some children no being allocated places. It was agreed that the Clerk would write a letter of thanks to the Rugby Club in recognition of their support and the use of their facilities to accommodate the Play Group.

A question was raised regarding the Play Group and the numbers they were able to cater for each day was confirmed as 40. The charge per child was 50p per day and it may be something the Activity Committee wants to reconsider for next year.

The Community Show was also a great success with more entries than in previous years. The Chair thanked all those who had helped out with the organisation of the event. The accounts will be produced and reported by the Chair at the next meeting. It was resolved that remuneration for the Caretaker would be discussed at the next Activity Committee. It was also agreed that a letter of thanks be sent to Alan Hoskins in recognition of his help and support with the Community Show

It was confirmed that the plaque would be removed from Salem Chapel and placed on display in the school.
